

## TERMS & CONDITIONS – ART IN SCIENCE COMPETITION

These terms and conditions govern the requirements for entry into the ‘Art in Science’ competition.

This competition is owned and managed by the Westmead Research Hub (WRH).

This competition starts at 9:30am on 14 August 2018 and closes at 11:59pm on 10 September 2018 (“**Entry Period**”) unless stated otherwise by the event organisers.

### 1. Entry requirements

All entrants must meet the following requirements:

- All entrants must be aged 18 years and over.
- All entrants must be affiliated with a WRH Partner organisation.
- Entrants confirm that any person depicted or visible in photos consents to their image being used in the competition and any promotion of the competition thereafter.
- All entrants agree to grant to Westmead Research Hub a perpetual, royalty-free, non-exclusive licence to reuse the image for any Hub related ventures, including but not limited to the Art in Science Competition
- Upon request by affiliated WRH Partner organisations, your contact details may be given to those organisations to be able to contact you and request use of your image for their purposes.
- Winners agree to take part in any publicity activities and to the use of their names and photographs in such publicity as reasonably required by WRH.

All entries must meet the following requirements:

- Entries must not have been entered in any previous Westmead Research Hub Art in Science Competitions
- Each entry is to consist of one digital image and one completed entry form.
- The digital image must be a single-plane image in JPEG or PNG file format.
- All video images must be submitted as a Youtube or Vimeo link.
- The digital images must contain at least 1024 pixels in the X dimension and 1024 pixels in the Y dimension (e.g., pixel resolution 1024x1024 or higher).
- The digital image file size must be less than 20 MB.
- Each entry is to be submitted for competition in one of four categories:
  - Digital Imaging
    - Image acquired on instrument(s) at the Westmead Research Hub Campus including the transmission electron microscope, whole animal imaging, or light microscope modalities such as transmitted light, DIC, phase contrast, fluorescence, confocal, DeltaVision, super resolution, light sheet, or high-throughput screening.
  - Data Visualisation
    - Representation of actual data acquired at the Westmead Research Hub Campus in forms such as graphs, charts, tables, plots, infographics, 3D models or reconstructions

- Science Life
  - This category is quite broad and includes any aspect of life at the Westmead Research Hub.
  - This can include but is not limited to:
    - Images that demonstrate what the researcher's work is all about
    - Images that represent the impact of researcher's work on people, health, environment or economy
    - Images that demonstrate the researcher's experience doing field work or collecting samples
    - Images of buildings, labs, redevelopment work, or fun in the lab
- Short Video
  - This category is quite broad and includes videos on any aspect of research or life at the Westmead Research Hub.
    - Videos must be under 3 minutes to be eligible for entry
    - Videos from experiments including but not limited to live cell microscopy, 3D volume imaging or data reconstructions and projections etc.
    - Videos that demonstrate what the researcher's work is all about
    - Videos that represent the impact of biomedical research on people, health, environment or economy
    - Videos about working at Westmead, working in the lab doing field work or collecting samples
    - Videos of buildings, redevelopment work, or fun in the lab
- To be considered in more than one category, separate entries must be submitted for each category.
- Entries must be submitted online via [westmead.org.au/events/art-in-science-competition](http://westmead.org.au/events/art-in-science-competition)
- Entries must be received by 11:59pm on 10 September 2018.
- All images submitted must be the entrants' own work; OR the entrant has the rights to submit the work.
- Scientific images must conform to ethics requirements related to the research project from which the images were derived and both image and description must be de-identified and not contain references to personal health information.
- Entries must not contain any material which is defamatory, offensive or inflammatory.
- WRH reserves the right to exclude from the competition any entries if deemed unacceptable and inappropriate per the above clause, or for any reason do not meet the requirements listed in these Terms and Conditions.

## 2. Judging criteria

- Digital Imaging, Data Visualisation, and Science Life Categories:
  - The judges of this competition will take the following into account in deciding the winning entries:
    - Composition
    - Artistic impact
    - Images/Video/Data accompanied by the clearest, most informative and most vibrant descriptions and titles
- People's Choice Category
  - The image that receives the highest number of votes during the public voting period (September 17-October 5th, 2018).

- The judges' decision is final and no correspondence will be entered into.

### **3. Winner notification and prize details**

- Prize-winning entries will be announced at the Art in Science Winner Announcement event to be held at 3:00 pm on Thursday 11th October 2018 at the Westmead Institute for Medical Research.
- If not present at the event, prize-winning entrants will be notified by email thereafter within a reasonable timeframe.
- If a prize is not claimed after fourteen (14) days following WRH notifying the winner, WRH reserves the right to retain the prize.
- Four entries for each category will be shortlisted. The winner for each category will receive a \$200 gift card a set of Bose headphones.
- The Peoples choice winner will receive a \$50 gift card

### **4. General**

  - variation in prize value to that stated in these terms and conditions;
  - entrant's or other person's participation in this competition;
  - damage caused to any prize in transit before the prize winner takes possession;
  - tax liability incurred by a winner or entrant;
  - use or misuse of the prize;
  - invalidation of any entry;
  - disqualification of any entrant; and/or
  - any cancellation, termination, modification or suspension of this competition.
